PHILANTHROPY IN ACTION AWARD

Philanthropy is often defined as the voluntary giving of time and financial resources to promote the well-being of human kind. If charity begins at home, philanthropy begins in the community through individuals, families, corporations and youth.

The Fredericton Community Foundation (FCF) will recognize and celebrate philanthropy in our community with the Philanthropy in Action Award. Nominate a deserving individual, family, business or group to be recognized for their philanthropic contributions to our community (registered non-profits and charities are not eligible for this award.)

ELIGIBILITY & NOMINATION CRITERIA

Any individual, non profit organization, company or staff/board member of the FCF may submit a nomination for the Philanthropy in Action Award. Nominees must be residents of the Greater Fredericton Area.

The nomination should include the following information with specific examples from the nominator's organization or personal experience:

1. The impact the nominee has made in the Greater Fredericton community.
2. Evidence of leadership in philanthropy (Board Member, matching gifts, fundraising, etc.).
3. Demonstrated history of personal philanthropic giving.
4. Involvement in volunteering.

SELECTION CRITERIA

The Award Selection Committee will be comprised a minimum of five (5) community members independent of the FCF. The Chair of the Philanthropy in Action Committee will coordinate the Award Selection Committee but will not vote. The Award Selection Committee will review the nominations based on the eligibility criteria set out above. All areas of criteria have equal weighting.

SUBMISSION DEADLINE AND PROCESS

DEADLINE FOR SUBMISSIONS – OCTOBER 31, 2016
